REFLECTIONS



I write this 2019 reflection in September 2020, a little more than a year since my experiences at camp last summer. I was full of plans for how I would spend this first year of retirement. I had no idea that my plans and the plans of so many would be entirely upended.

But in 2019, my last summer, I gathered up the experiences and memories, the sights and sounds and smells of a place I deeply love, and that our campers and staff love as well.

What could I tell you now about 2019? That it was a consequential year for Sherwood Forest to be sure. That it would be the first year we would have the opportunity to use a new village, dining hall, health lodge, and program center- the MAC, which houses our camp library, reading room, and science and computer labs. Those new spaces are wonderful. And even more wonderful, how incredible it was to watch campers rapidly adjust to new ways of being in them.

Blue and green aprons now designate who has which responsibilities during meals. On Day 3 I watched our boys settle in for breakfast as though they had always worn blue or green aprons, even if they were wearing them as capes or turbans. That morning I watched with tears in my eyes knowing that I would never again see another Day 3 of Boys Camp from my vantage point as Executive Director.

Late one night as I was walking back from the barn, I saw a light on in the MAC and went to investigate. There I found Sam Booher, a Counselor in Training, sitting at a computer in the library. He told me that he was adapting some of our STEM (Science Technology Engineering and Math) activities to make them more fun for the campers. Later in the summer, he spoke with a donor, to explain the activity he was leading. I was thrilled that our visitor asked if the staff were helping the kids to have fun in their activities and knew that Sam was more than ready with his answer.

When our alumna, Sheryl Gatewood Williams came to visit us, she met with our Leadership campers and told her story of being a Leadership camper and then young staff member, how what she learned those days helped guide her into her career as a Judge Advocate in the United States Marine Corps and afterwards in

her public service as an attorney in Civil Rights Division in the Department of Transportation. Sheryl, who holds numerous “first ever” accolades in her career, reminded our campers that once she was just like they were, as young, and inexperienced, and eager to step into the world.

Camp ended as it always has, with a Closing Council Fire.

This oldest and most cherished tradition has been passed down since 1937, intact, from one generation to the next. It was affirmation of all I know that is good and strong and enduring about Sherwood Forest.


It is part of the tradition that the villages all gather and then walk in silence to the council fire. In 2019, as has happened so many summers our rambunctious campers came in quietly, and reflective. Songs, the magic Spirit of the Fire manifested. Friendship, Cooperation, and Learning- Spirits all present. Carefully chosen stick dedications from each cabin group and staff member. A chorus of yipping coyotes on the western ridge joined in the ceremony.

As I said in my stick dedication, “Sherwood Forest is part of you. It is with you always, and part of you is here always.” I felt and held the sense of the community of us, the family of us, present in body, and gathered in spirit. As I walked back in the dark a barred owl hooted above our new Summit Village. The campers settled in for their last night of sleep under a brilliant, star lit sky serenaded by the chorus of frogs and crickets. The sounds of our camp home.

Like every summer, staff and campers alike faced some big challenges and significant hurdles along the way. This is how we learn what we are made of, and so often we find we are made of stronger stuff than we imagined. A summer of fun and friendships and challenges, failures and successes, all mixed together in the unique environment of camp, changes both children and adults. Those experiences become life lessons and we carry them throughout our lives.

We must draw on these life lessons now, for the rest of 2020, and beyond. Sherwood Forest’s ability to respond to these times and challenges, matters now, perhaps more than ever, for our young people. After all, we help young people every day learn to chart their course into the future, both literally and figuratively.

We are born for these moments. Yes, 2020 has been nothing like we imagined it would be. But from dark depths come the sprouts of new ways into the future, always learning and growing, ever onward and upward.

Creating Lasting Memories in our New Buildings

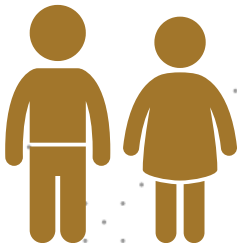
Our campers experienced their first summer using the new Dining Hall, Health Lodge, and the MAC, where our Library and STEM lab are housed. Because of the generosity of our Way More Than Camp Capital Campaign donors, we raised more than \$7.2 Million to update our camp. This investment ensures Sherwood Forest's expanded impact in the community, evidence-based programs, and school-year outreach to children from low-income families and underserved communities in the St. Louis area. In addition to the above buildings, we were also able to repair our lake, add new staff housing to support our increasing programs, and add a \$1 million endowment fund to help ensure Sherwood Forest's long-term financial sustainability and to serve as the foundation for future planned-giving efforts.



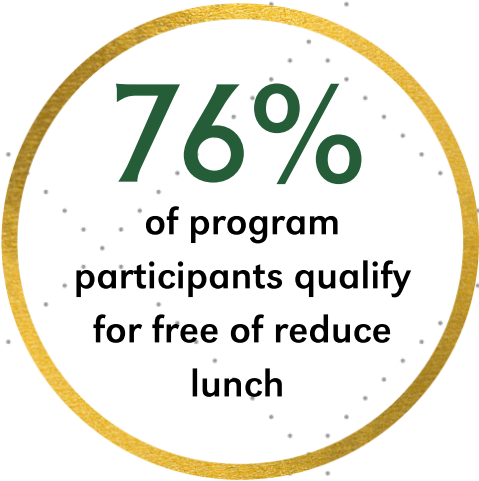

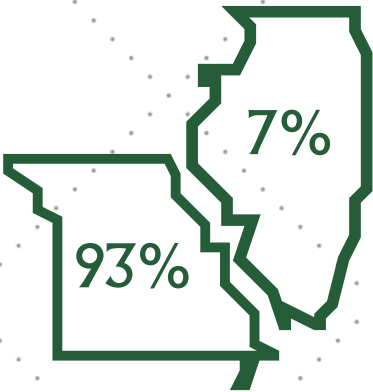

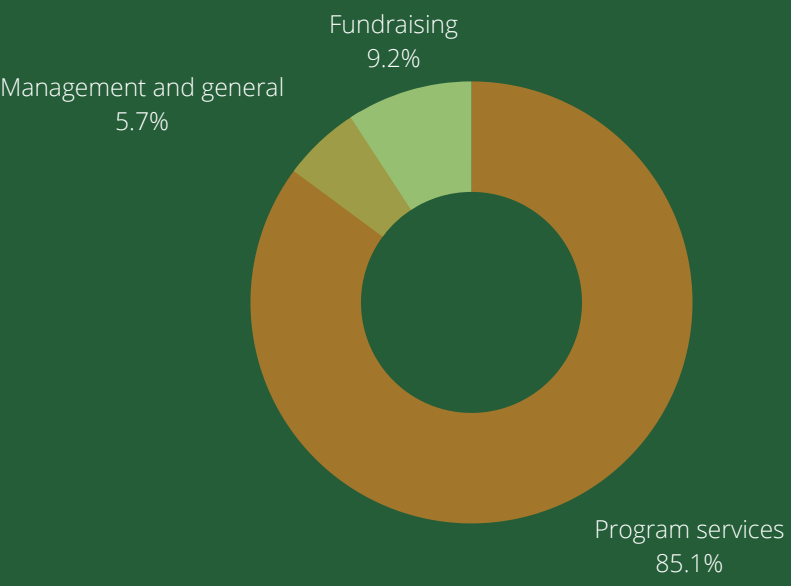
