## LETTER FROM THE EXECUTIVE DIRECTOR

2020 was a year that changed the world.

COVID-19 challenged all aspects of life from how we as a society interacted, worked and learned. Sherwood Forest was no different. During this unprecedented year, our Board and Staff creatively designed programs to serve our campers in ways never seen or needed before.

For the first time since our beginnings in 1937, we did not hold an in-person summer residential camp. Although it was a hard decision, the health and safety of our campers and staff was foremost on our mind. Instead, campers were invited to join in our first-ever “Stay Camp” – an all virtual camp hosted by our program staff and volunteers. Each camper was given a “Buder Box” (named for our famous Buder Lake at camp) that contained all the necessary supplies and equipment to participate in daily virtual camp activities.

This impressive feat was made possible by the donors listed in these pages. More than once, a friend of Sherwood Forest called in the early months of the pandemic and simply asked in the true Sherwood Forest spirit “How can I help?” Because of our donors, we were able to host Stay Camp and fall virtual clubs at a time when our campers needed us most. This support means so much to us and to our campers.

## A YEAR LIKE NO OTHER

Sherwood Forest made the call early on in spring 2020 to transition programs to an online format, swiftly making outreach to camper families and strategizing the best ways to provide kids a camp community at home. COVID-19 had shuttered school and extra-curricular programs and our region was in a lockdown the likes of which many have never seen.

Sherwood Forest Board of Directors and Staff quickly realized that our in-person, residential camp would need to transition to meet the needs of our campers in this unexpected situation. Stay Camp 2020, our first ever all-virtual camp program, challenged staff and campers to stay connected, keep minds engaged, and cultivate the spirit of camp in our homes. While spending the summer apart was never what we anticipated, it proved that camp bonds are stronger than we ever thought possible.

Our Stay Camp 2020 programming offered a variety of activities to keep campers involved and connected - ranging from a book club and art projects to science experiments and even yoga. Each child registered for camp and those on the waitlist, were delivered a “Buder Box”, which included the supplies and instructions for joining online meetings so they could participate in Stay Camp. What really kept the Sherwood Forest experience alive for campers, however, was the community time with their friends, also known as “Logs”. By starting and ending their days in this shared virtual space, they were able to plan their day, reflect on what they learned, and simply have fun together.

During the fall, Sherwood Forest continued virtual programs by offering weekly themed clubs that campers chose based on personal interests. Similar to the boxes they received over the summer, campers were given all the supplies they needed to participate.

While campers and staff felt the weight of the loss of the typical summer, Sherwood Forest continued to show its empowering spirit to overcome such an enormous challenge and continue serving kids when they needed us most.
