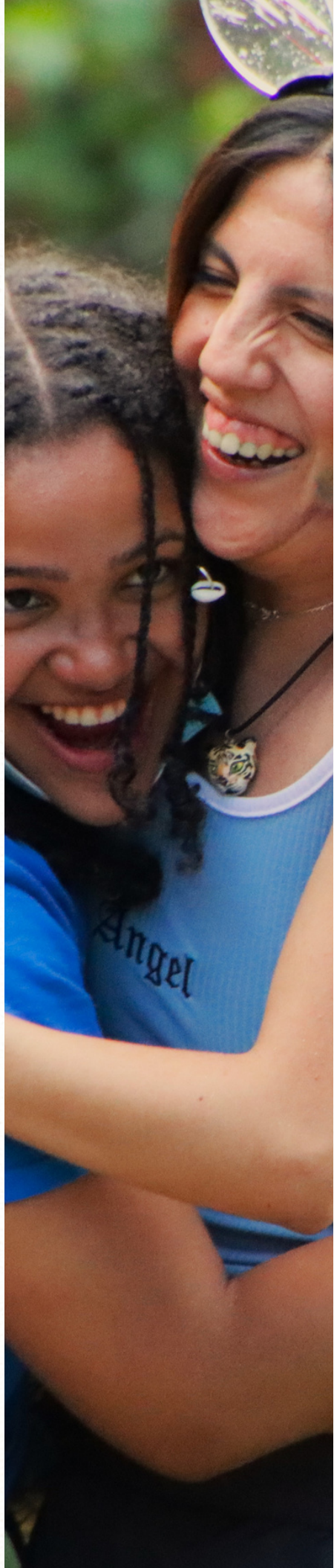

2022 Review

2022 exemplified our commitment to helping kids discover the best in themselves. By maintaining long-term relationships with our campers, families, and community partners, Sherwood Forest succeeded in connecting, educating, and inspiring the youth of St. Louis through a diverse range of programs.

The 2022 camp season kicked off with an enchanting week-long mini camp specially designed for our youngest campers in 1st and 2nd grade. Filled with adventures, outdoor exploration, and engaging activities, this program provided a safe and fun environment for our campers to discover new interests and build friendships.

The heart of our summer season comprised two transformative 24-day sessions catered to campers ranging from 3rd to 9th grade. These sessions balanced traditional camp adventures with evidence-based educational programs, offering a holistic experience that fostered personal growth, resilience, and teamwork among the campers.

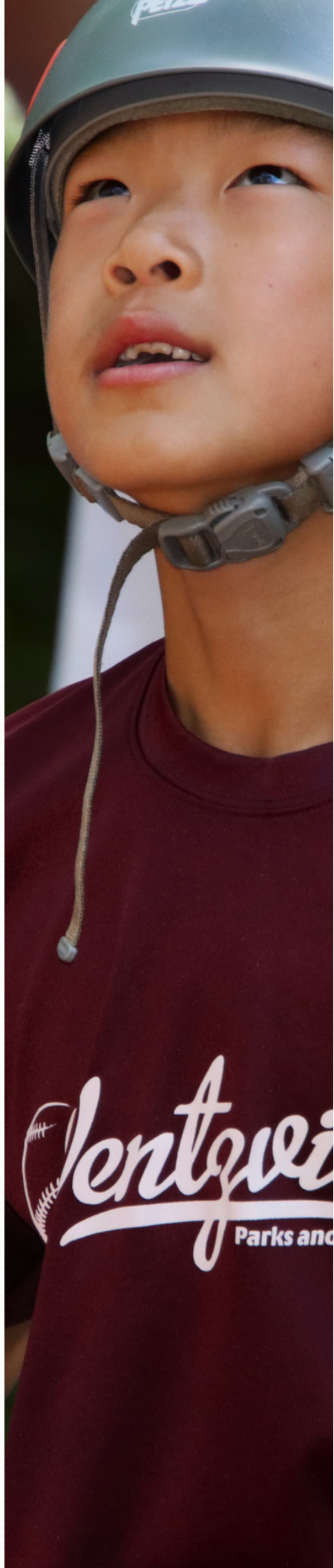
3rd-grade campers participated in a reading program centered around discussions, activities, and creative projects, the program encouraged a love for literature and enhanced the campers' reading and comprehension skills along with a love of nature.

4th and 5th-grade campers delved into the fascinating world of Science, Technology, Engineering, and Mathematics (STEM). Hands-on workshops and interactive experiments sparked curiosity and critical thinking, inspiring a passion for these disciplines among our young learners.
